1. Introduction

We are the Office for Health Improvement and Disparities (OHID) in the Department of Health and Social Care. We have a database called the National Drug Treatment Monitoring System (NDTMS), which we use to collect information about drug and alcohol treatment in England.

The National Drug Treatment Monitoring System (NDTMS) data helps drug treatment demonstrate the outcomes it achieves for the people it treats and in doing so aids accountability for the money invested in it. NDTMS is a national standard and is applicable to young people and adults within community and secure setting-based treatment providers.

This document establishes the text to codal values (the reference data) in use with the NDTMS dataset and will support software suppliers in implementing the dataset.

Reference data is defined as (relatively) static data. Generally, it is employed as a means of validating data entry and will typically be used to control the contents of drop-down lists for example. This document gives the permissible values for each of the reference items in the NDTMS datasets, only values for the relevant dataset should be included in the CSV file. The document is split into the following sections: community, secure setting and outcomes.

Data items are applicable to young people and adults within community and secure setting-based treatment providers. The dataset inclusion column provides information regarding which items are relevant to each dataset whereby:

- AD = community adult dataset
- YP = community young person dataset
- SA = secure setting adult dataset
- SY = secure setting young person dataset

This document is intended to be a definitive and accessible source for use. It is not intended to be read from end to end, rather as a reference document which is utilised by a variety of readers, including:

- Interpreters of data provided from OHID systems
- Suppliers of systems to OHID
- Suppliers of systems which interface to OHID systems
- OHID/National Drug Treatment Monitoring System (NDTMS) personnel

This document should not be used in isolation, it is part of a package of documents supporting the NDTMS dataset and reporting requirements.

- NDTMS CSV File Format Specification – defines the format of the CSV file used as the primary means of inputting the core dataset into NDTMS
- NDTMS technical definitions – provides the full list of fields that are required in the CSV file and the verification rules for each item
- NDTMS geographic information – provides the locality information eg DAT of residence and Local Authority
- NDTMS business definitions – provides the explicit definition of each of the fields we collect to ensure data is consistent. There is a separate definitions document for each of the datasets: community adult, community young people and adult and young people secure settings

2. Change Control

Each significant change to the NDTMS dataset is allocated a letter. The current version (commonly referred to as NDTMS dataset Q) for national data collection will come into effect on 1 April 2022.

As this document is the ultimate definition for NDTMS reference data the behaviour of the NDTMS system must strictly adhere to the latest approved version of this document on [NDTMS.net](https://ndtms.net).

For those data items defined by OHID (internal data), the details contained in this document are the master definitions of such data, extending to issues such as upper/lower case, hyphenation and punctuation.

For those data items not defined by OHID (external data – see [Appendix B](#)) this document defines the owner of the master data.
