## NDTMS Core Dataset Q: components for YP providers

<b>YP Pharmacological Intervention</b> These are substance misuse specific pharmacological interventions which include prescribing for detoxification, stabilisation and symptomatic relief of substance misuse as well as prescribing of medications to prevent relapse.	
<b>YP Psychosocial Intervention</b> <ul style="list-style-type: none"> <li>• Cognitive and behavioural interventions</li> <li>• Motivational Interventions</li> <li>• Structured family interventions (including family therapy)</li> <li>• Multi component programmes</li> <li>• Contingency management</li> <li>• Counselling</li> </ul>	
<b>YP Specialist Harm Reduction</b> Care planned substance misuse specific harm reduction is not brief advice and information; this intervention must be delivered as part of a structured care plan and after a full assessment of the young person's substance misuse and risks. Specialist harm reduction interventions should include services to manage those at risk of, or currently involved in injecting, overdose or Risky behaviour associated with substance use.	
<b>YP Multi-Agency Working</b> <ul style="list-style-type: none"> <li>• Education / training</li> <li>• Employment / Volunteering</li> <li>• Housing</li> <li>• Generic family support</li> <li>• Generic parenting support</li> <li>• Peer support involvement / mentoring</li> <li>• Mental Health</li> <li>• Offending</li> <li>• Health</li> <li>• Sexual Health / Pregnancy</li> <li>• Meaningful Activities</li> <li>• Disability Services</li> <li>• Behavioural Services</li> <li>• Young carers</li> <li>• Youth services</li> <li>• Children's social care</li> <li>• Stop-smoking service</li> <li>• Domestic abuse support for victim/survivor</li> <li>• Domestic abuse support for perpetrator</li> </ul>	Multi agency working lists work done by the substance misuse provider with other services needed in the young person's care package. This work includes facilitating access to the service, arranging appointments or making referrals to the service, working directly with the service in joint case reviews and liaising with the service to discuss the whole needs of the young person.  This intervention type is non-structured and should support other specialist substance misuse interventions.  <b>If a young person receives just this intervention type they will not be classed as "in treatment".</b>
